

### Online Master's Degree in Special Education with Professional Certification as Educational Diagnostician Program Overview and FAQs

**Program Description:** The Masters of Education Degree with a major in Special Education is designed for the practicing teacher to build professional knowledge and practical skills. Completion of degree requirements will allow the candidate to become certified as an Educational Diagnostician. Candidates who are not practicing special educators may be required to complete leveling courses. As a student of the program you will:

- Apply what you learn through meaningful practicum experiences
- Be up to date with the literature of the field and evidence-based practices.
- Understand the issues, trends, and research that influence contemporary education.

### How can you deliver this instruction online effectively?

The success of online learning is determined by many factors including a) student motivation, b) responsiveness of instructor, and c) program design.

- a) Student Motivation: Students who have completed this program have been highly motivated and dedicated to the field of special education. They posses and develop many of the skills that are necessary to be a successful educational diagnostician especially time management and organizational skills. They take an active role in their own learning by asking questions, researching, and collaborating.
- b) Responsiveness of Instructor: Midwestern State University has always prided itself on its small classes and individual attention it pays to students. This program maintains these points of pride. Some students need more support from instructor, while other students seem to thrive on independent study. Our small class sizes allow the needs of both of these students to be met.
- c) Program design: The program is designed with the Texas Educational Diagnostician Standards as the foundation along with Diagnostician and Special Education Leadership standards of The Council for Exceptional. Upon completion of the program, students will have been taught the required standards and completed the required practicum hours to be eligible to become certified as an educational diagnostician. #### How is instruction delivered?

Instruction is delivered using a variety of methods. Instruction for this program can be described as meaningful, rigorous, and flexible in its delivery. A brief description the types of methods appear below:

- a) Traditional Online instruction Tools using *Desire to Learn* that allows for posting of information, discussion boards, online assessment, email, and communication tools.
- b) Textbooks/Professional Library: An educational diagnostician needs a professional library in order to be effective. Textbooks are best viewed as tools and as an investment in this program and will become part of your professional library.
- c) DVD/CD/Video Instruction: Courses in individualized assessment have traditionally have been delivered in the classroom with the instructor demonstrating, student practicing, and then the student practicing with real children. Test companies now supply training videos and webinars to teach how to administer and score their testing instruments (WISC-5, WJ-IV, and KABC). This instruction is usually provided by the author of the test who is regarded as the authority on the instrument. Instruction via distance is very similar to the instruction in the classroom. The following sequence to teach each instrument is: 1) become familiar with test kit and manual, 2) watch Video (pause and practice), 3) recruit real subject and practice, 4) score and report, and 5) reflect.

\*Once you learn the basics of test administration and have practiced using several instruments, you will be able to use these skills to administer and score other instruments. As you go through your career, new and revised instruments will come out periodically. You will actually go through this same sequence as a practicing diagnostician.

- d) Video-Conferencing: Using video sharing software, webcam, and microphone, we have the ability to communicate, share a computer screen, observe, record, and teach.
- e) Practicum experiences: The online option (and traditional option too) requires extensive field experiences including testing students from a wide range of age groups and backgrounds, parents, and supervised experiences with educational diagnosticians. This is in addition to the hands-on experience you will gain from the other courses. This will ensure your competency and confidence as an educational diagnostician.\*
- f) We also have optional-but encouraged live seminars throughout the school year on Saturdays.

\*Practicum supervision will be coordinated with instructor, student, and cooperating district (district you work in).

**Will I be required to go to campus?** For SPED 6013 Individualized Diagnostic Assessment 1 and SPED 6023 Individualized Diagnostic 2 you will be **required\*** to come to the MSU campus or the Flower Mound Campus (sessions will be live streamed as well) for a Saturday Seminar early in the semester. Other **optional** seminars will be offered throughout the semester which you are encouraged to attend.

\*For students who have extensive travel needs, attendance at required seminar can be virtual.

### What is the admission requirement for the West College of Education?

All students seeking admission to graduate programs in the West College of Education must meet three types of admission requirements: University requirements, West College of Education requirements, and specific program requirements. University requirements for admission to graduate study are in the Academic and University Information section.

All students seeking admission to graduate programs in the West College of Education must meet 1) University requirements, 2) West College of Education requirements, 3) and specific program requirements. University requirements for admission to graduate study are in the University and Academic Information section (see Admissions & Academic Information).

In order to become **admitted** to the Educational Diagnostion program, you MUST be a certified to teach and provide a service record.

- 1. Students who have **earned a 3.0 GPA** on an undergraduate degree from an accredited university may be **automatically admitted to** a West College of Education graduate program. Students who have earned less than a 3.0 GPA on an undergraduate degree from an accredited university should submit scores from the GRE ScoreItNow! Students who do not make a satisfactory score on the writing sample, may be required to take an approved writing intensive course and/or seek tutoring from the MSU Writing Center.
- 2. Admission to a specific program also requires a satisfactory background of undergraduate course work and experience. Admission to all programs requires 18 to 24 hours of acceptable undergraduate course work. Leveling work may be required if a student needs additional undergraduate background. State certification in Educational Leadership, Educational Diagnostician, and School Counseling requires appropriate teacher certification. Students must submit copies of service record and certificate. Specific program requirements are listed with each program major and option.
- 3. Students who enter as non-degree seeking or with professional development status and who are later admitted to the graduate program may request credit for a maximum of 9 semester credit hours of successfully completed coursework to be applied toward the graduate degree with the approval of the Graduate Coordinator and the Dean of the College.

### Admission to Candidacy

Admission to candidacy for graduate programs in the West College of Education will be determined by the Graduate Advisory Committee and will require

- a qualifying examination, taken in the first 6 hours of course work, to determine proficiency in writing. If the student does not pass the writing sample, remediation will be prescribed.
- that students not passing the GRE Writing Analysis or the GRE ScoreItNow! test (though they may continue with their course work) must take ENGL 2113, Composition Skills and make a B or better, the following semester.
- successful completion of 15 hours of course work.

**Grades for Graduate Study.** Only grades of A, B, and C are acceptable in graduate courses. No more than two grades of C may be applied to the Master's degree. Upon earning a third grade of C or lower, the Faculty Review Committee will recommend to the Dean whether or not the student should be dismissed from the graduate program.

### What if I already have a Masters Degree and want to become an educational diagnostician?

Students who already possess a master's degree can become an educational diagnostician via distance education too. A transcript review will be conducted and an individualized deficiency plan will be developed based on this review. A minimum core of 18 hours will be required of all candidates. In general, the more special education courses you have taken, the fewer hours it will require. (See below for more information)

### **Educational Diagnostician Deficiency Plan**

Students seeking diagnostician certification who already possess a Master's Degree will be required to complete courses to a) possess the necessary skills to be a high quality educational diagnostician, and b) be able to demonstrate competency of the state requirements. Each candidate will complete a minimum core of 18 hours (listed below) of courses in order to be considered for certification. Since candidates enter the program with various teaching certificates, educational backgrounds, degree types, and coursework a thorough transcript audit will be conducted and additional courses will/may be required pending approval of program coordinator and certification officer.

<sup>\*</sup>Please note, per TEA, Educational Diagnosticians who are seeking a probationary certificate (i.e., get a job prior to certification) must have completed the core 18 hours and must be supervised. Supervision is required for one full school year and a fee of \$1000.00 is required.

### How do I sign up for Courses?

### Advising Procedures

Upon acceptance into the program, you will be assigned a Mustang ID# (M#) which allows you to be advised and register for courses. You will need to familiarize yourself with the MSU portal in order to register (<a href="http://www.mwsu.edu/registrar/prewebworld/">http://www.mwsu.edu/registrar/prewebworld/</a>). You will be assigned an advisor that you will use throughout your program once you get admitted. Mary Wines will be your advisor if you are seeking Dyslexia ONLY.

Please follow the steps listed below in order to be advised.

1. Access course schedules online (these are usually available in Mid- March, and Early October).

- 2. Select courses that are offered for your degree plan. Check the catalog for pre-requisites. Generally, six hours is the maximum hours allowed for a semester.
- 3. Email your advisor with your proposed/preferred courses. Please include your M# in this correspondence as it will expedite the process. Course selections will be reconciled with your degree plan and current transcript.
- 4. Permission will be given to register for courses (or alternate selections) and your advising hold will be removed. You will not be able to register until your advising hold is removed.
- 5. Use Web world to register for classes.

### **Additional Advising Information**

It is important that you consult the university catalog as it is ultimately the student's responsibity to register for the proper courses. Some courses are offered once a year so these should be taken when available as to not delay graduation. Courses are offered in a manner which allows timely progression through the program. Please schedule a phone call if you need further assistance beyond email and make sure that you follow the recommendations of your advisor instead of your well-meaning colleagues.
